ADMISSION NOTICE FOR NCCCMP COURSE BATCH-20


NCCMP (NSE Academy Certified Capital Market Professional) is a short duration weekend course on Capital Market conducted by "Shaheed Sukhdev College of Business Studies (SSCBS), University of Delhi" in collaboration with "NSE Academy Ltd." - **Duration of the course:** 4-6 Months (100 Hours: 80 hours of theoretical sessions and 20 hours of practical sessions). Practical sessions may be held on week days.

- Class Teaching Mode: It will be class room-based teaching only however college may change class room-based teaching to online teaching as per the situation. A student has no right to claim refund of fee if mode of teaching is changed.
