After detailed deliberations and considering the demand of this course which would be helpful in increasing the knowledge base and employability of the students, the Governing Body approved the starting of this new course and accompanying budget, initially for two admission cycles/sessions only and then to be reviewed by the Governing Body.

(7) To consider and approve the recommendations of the Library Committee for purchasing of books from the previous year vendors for supply books in the college library on the same terms & conditions of Delhi University Library System till the renewal of vendors for 2015-16 is finalized in the University system and also suggested that in future, if the same situation arises, the same practice, may be followed.

The Governing Body approved the recommendations of the Library Committee for purchasing of books from the previous year vendors keeping in mind the interest of the students' community till the renewal of vendors list by the University. It was further resolved that in case the same situation arises in future, the same practice can be followed.
