## ITEMS (OFFICE)

3) To consider and approve the starting of new courses in the college as per the directions of the Directorate of Higher Education, Govt. of NCT of Delhi in terms of capacity expansion subject to shifting at the new campus of the College at Rohini.

The Principal informed the Governing Body that the college has received directions from DHE, Govt. of NCT of Delhi to start some new courses on account of the college moving to the new building with increase intake of students. She informed that the matter was discussed in detail in the Staff Council meeting of the college and the following courses were unanimously approved by the Staff Council:

- a. Business Analytics.
- b. Operational Research.
- c. Financial Mathematics.
- d. Entrepreneurship.

However, there was no consensus in the Staff Council of the college whether to start B.Com (H) course or not. Principal informed the Governing Body that after voting, 12 teachers were in favour to start the said course while 2 teachers were of the view that this course should not be started while the others present were neutral on this poonam Verma

issue. Therefore, the said matter was raised before the Governing Body to decide by its wisdom.

Detailed discussions were held in this regard and it was resolved that the character of the college has always been to have professional and unique courses. The efforts, thus, should be to enhance this character and not dilute by starting courses which are being run already in numerous colleges and also at SOL (Distance Education). The Governing Body also felt that just because 12 teachers are in favour of starting a course and the majority of them preferred to stay neutral and not positive of starting a course is an indication that these 'run-of-the mill' courses should never be started in this college which has maintained its lead and uniqueness in this entire University. Moreover, the students admitted through the present BMS/BBS/BBA (FIA) courses are through an entrance exam and efforts should be made to have such courses where admitted through an entrance exam and not through the merit in their last qualifying exam of class 12th. The Governing Body applauded the four courses that were unanimously approved by the Staff Council and felt that even in future, courses which add value and increase the employability of the students should only be started. The Governing Body was of the view that only professional and career oriented courses should be there in the college which should have academic merits.

4) To consider and approve the starting of classes for Non Collegiate for Women on Saturday & Sunday in the college as per the directions of the Directorate of Higher Education, Govt. of NCT of Delhi subject to shifting at the new campus of the College at Rohini.
