- 4. The Audit Report (AGCR) on college accounts for the period 1987-88 to 1992-93 was considered and the observations of the college there on were approved.

Members desired that steps taken not only w.r.t. the compliance of audit objections but also w.r.t. recommendations of any other external body should be reported to the Governing Body in its next meeting.

- 5. The recommendation of Screening Committee regarding promotion of Mr. H.K.Porwal as senior lecturer in the grade of Rs. 3000-5000 was considered and approved.
- 6. The extension of service of Ms.Kishori and Ms.Anuja Mathur, both lecturer, for the academic session 1994-95 or the meeting of Selection Committee for appointment of lecturers in Business Studies whichever is earlier was approved.

Resolved further that vacancies for lecturers be advertised and in the mean time ad-hoc/guest arrangements be made.

7. The letter dated Ø5/08/1994 given by the Librarian of the college was considered.

Resolved that a committee consisting of Sh.M.S.Panwar and Sh.Jagdish Upasane be formed to look into the details and suggest actions to be taken.

- (3) C.B.S. Employees' Provident Fund Account : Savings Bank Account No. 13812 with Canara Bank, Jhilmil Industrial Area, Vivek Vihar, Delhi Shall be jointly operated by the Treasurer and the Principal.
