Minutes of the meting of the newly constituted Governing Body, held on 24/05/99 at 04:00 p.m. in the office of the Principal to elect the Chairman and to appoint the Treasurer of the college.

At the outset the Principal introduced the members with each other and welcomed all the members for joining the college Governing Body. He also briefly apprised the new members about the college, its courses and the prospects of growth. Members appreciated the efforts made by the college and assured of their fullest co-operation.
