3) Knowledge Sharing Sessions:

IMA Team conducts regular Knowledge Sharing Sessions to boost its member's business acumen and help them develop industry-relevant skills. Following were the topics upon which KSS was held in the academic year 2022-23

- 1) MS Excel: MS Excel is one the most basic yet useful tools in the corporate world. An efficient user can perform multiple calculations in a matter of seconds by creating a proper formula. To equip our organizing committee with this vital skill multiple knowledge-sharing sessions were held. The session went from basic commands such as SUMIF to many advanced commands like V-Look Up/how to use a solver.
- 2) **Financial Modeling & Valuation:** Financial modeling is a demanding skillset and there has been a significant increase in the number of financial modeling competitions. So to take advantage of the uprising

opportunities multiple knowledge-sharing sessions were held by the core and advisory committees. The session discussed 3 statement models and Discounted cash flow.

- 3) **Financial ratios and Stock Market:** Based on the demand of the organizing committee a session was organized by the coordinator. In the session, many ratios were discussed then followed by a general discussion on how to analyze a stock.
- 4) **Canva:** Graphics play an important role in one's life ranging from college projects, case competitions, or as a career. One should be handy with graphics. With this view, they were given tips and tricks to use canvas in a better way.
- 5) Case competitions: Being the thriving chapter of eminent institution SSCBS where we leave no stone unturned to raise its legacy. 4) Live Projects:

IMA SSCBS recently collaborated with Finanddata, an organization that provides news and insights about the stock market, finance, and data science founded by Mr. Yash Gupta, for an equity research Live Project which equipped the members of IMA SSCBS with the knowledge of various macroeconomic indicators and usage of these indicators for analyzing an economy and a particular economy, financial ratios, performing sectoral/industrial research, financial modeling including the knowledge of models like Discounted Cash Flow Model and Comparable analysis Model, modeling the five-year forecast of a company and performing sensitivity and scenario analysis.
