#### **Other Initiatives:**

- **Investment Fund-** FinX has an Investment Fund and takes active positions in the Indian Stock Market. Regular discussions are also held to deliberate on the current news and happenings and their effects on stock prices. This gives our members a real-time approach to the capital markets with the required know-how
- Live Projects- We undertook 2 live projects for a duration of 8-12 weeks on a time-to-time basis.

The first project was with Acqux, which is an Identity Resolution SaaS to make brands marketing efforts more efficient by elevating User Acquisition AI technology. The team built CPIs and a thorough GTM strategy for the company.

We have also undertaken a project with Cinnamon Kitchen wherein the team is involved with preparing a GTM strategy to expand brand presence as well as distribution through availability.

These projects helped us to gather corporate exposure and gain insights into ever-changing industries.
