4. Eligibility Criteria

Admission to this Program shall be based on the merit percentage of the marks obtained in qualifying degree examination.

Program Specific Eligibility	Minimum Eligibility
Graduation or above in Computer Science/Information Technology/Computer Applications/ Software Development/ Computer Engineering or equivalent	Minimum Eligibility* For candidates belonging to UR/OBC-NCL/EWS category, the minimum eligibility is 50% marks aggregate or equivalent grade in the qualifying examination as per the Program-Specific Eligibility. For candidates belonging to SC/ST/PwBD category, the minimum eligibility is 45% marks in aggregate or equivalent grade in the qualifying examination as per the Program-Specific Eligibility.

6. Procedure for admission

Admission will be based on the merit of the percentage of scores obtained in the qualifying degree examination as per the program specific eligibility criteria.

7. Important points

- Candidates are advised to fill in their forms carefully. No correction after the submission of the form will be allowed. Personal Details such as Name, Category, Gender, mobile number, email Id and details of the Bank Account once selected/entered at the time of Registration will not be changed in any circumstance. Registration Fee once deposited will not be refunded/ adjusted in any circumstances.
- The schedule of Allocations will be announced later. Candidates are advised to keep checking the admission website (admission.uod.ac.in) on regular basis.
