INTRODUCTION

Rohini Police Department, in association with the Lawrence-The Law Forum of SSCBS, organized an Awareness Session regarding the New Criminal Laws by unveiling about the audio-visual content creation competition. This initiative aimed to educate citizens, especially students and community members, about key provisions, rights, and safeguards under the updated legal framework.

The session was designed to foster legal literacy, build trust between the police and the public, and encourage active community participation in justice-related matters.

- During the session, participants were briefed on the significance of the reforms and how the new laws impact day-to-day life. Real-life scenarios were shared to explain practical aspects like FIR registration, digital evidence, women and child safety, and citizen rights.

KEY HIGHLIGHTS

- Engaging explanations by police officers simplified complex legal concepts.
- Interactive Q&A sessions encouraged students to clarify doubts and share concerns.
- Participants expressed appreciation for the initiative and showed readiness to spread the message further.
- The joint effort enhanced trust and collaboration between the police and the community.
- Attendance of 100+ participants, reflecting strong community interest and outreach.

CONCLUSION

- The awareness session, jointly organized by Lawrence and the Rohini Police Department, successfully familiarized participants with the three new criminal laws. The event achieved its goal of empowering citizens with knowledge, strengthening the citizen–police bond, and ensuring that awareness reaches the grassroots level.
