The College Functions Committee presented the detailed budget for the upcoming event and apprised the Governing Body of its special significance this year, as the Hon'ble Chief Minister of the Government of NCT of Delhi, along with other distinguished guests including Members of Parliament and MLAs, are expected to grace the occasion. The Principal elaborated on the rationale for the proposed expenditure, underscoring the need for adequate arrangements in terms of decoration, hospitality, and other logistical components. These were deemed essential given the importance of the event and the stature of the dignitaries likely to be in attendance. It was further noted that the proposed budget encompasses two major events i.e. the 39th Foundation Day and the Orientation Day for the incoming batch of students being held concurrently on the same day.
