The speaker for the session was an experienced legal professional who has completed her graduation and law degree from Panjab University, Chandigarh. With over a decade of experience in civil and commercial law, arbitration, mediation, matrimonial disputes, medical negligence, accidental claims, and consumer matters, the speaker brought a wealth of knowledge to the session.

She began her legal practice in 2013 under reputed law firms like SG Solicitors and AK Law Offices and has been independently practising since 2021. She has also been actively associated with the Delhi Legal Services Authority (DLSA) for the past two years.

During the session, the speaker elaborated on her extensive work with POCSO (Protection of Children from Sexual Offences Act), domestic violence cases, and awareness initiatives in schools and colleges. A key highlight was her outreach work with sex workers, educating them about their legal rights and duties. Her commitment to social welfare and spreading legal awareness was evident throughout the session.

Students and staff engaged enthusiastically in the Q&A, making the session highly interactive. The speaker addressed queries with real-life case experiences, making the legal framework more relatable and understandable.

Speaker: Dr. Jasdeep Kaur, Advocate and Academic Researcher

The second session under the ICC awareness initiative was held on 18th February 2025 in the college auditorium. The speaker for this session was Dr. Jasdeep Kaur, a seasoned legal expert with academic and professional achievements. She holds a B.A. (Hons.) in English from Mata Sundri College, University of Delhi, an LLM in Corporate Governance and Banking Laws from GGSIPU, and a PhD in Family Law from Amity University.

With over a decade of experience, Dr. Kaur has served as a Legal Officer with the Department of Women and Child Development (Govt. of NCT Delhi) and has been empanelled with various panels of Delhi Legal Aid Services. Currently, she is a Legal Services Advocate at the Additional Sessions Judge Courts, Rohini, North Delhi.

In her address, Dr. Kaur focused on issues concerning domestic violence, rape laws, women's rights, and the POCSO Act. She also shared insights from her research work published in several Scopus-indexed journals. The audience gained a deeper understanding of the current legal protections available to women and children and how systemic support can be accessed.

The session was highly informative, with numerous questions posed by the audience, particularly around redressal mechanisms and the practical challenges faced by victims. Dr. Kaur's in-depth knowledge and calm demeanour made the interaction enriching for all participants.

The event ended with a warm vote of thanks. Attendance was marked for all participants.
