Admission Notice (2026-27)

1. **Document Verification for the students will be held on 20th & 21st July 2026 from 10am to 4pm through online mode only-All files will be sent in pdf format only with in one single file. (student have to bring the documents in hard copy format at the day of joining the hostel)**
2. **Procedure for Admission:** Following steps need to be completed for hostel admission.
 - Download the admission form & attach all the documents listed below (as applicable)
 - **Candidate has to make an online payment of fees only after the verification of the admission form and documents.**
 - Proof of online payment of fees needs to be submitted through e-mail.
3. **Documents Required for Admission**
 - Hostel admission form, duly filled and counter-signed by parents / Legal Guardian / LocalGuardian
 - Acknowledgement of fee deposited in the hostel bank account (After the verification of documents)
 - Undertaking(s) as specified and signed
 - Medical fitness & Mental Fitness certificate from a Qualified Medical Practitioner (Original)
 - Duly filled Identity card (Any Govt. ID) proforma of student (with Signature)
 - Duly filled Identity card (Any Govt. ID) proforma of local guardian (with Signature)
 - Duly filled Identity card (Any Govt. ID) proforma of Parents (with Signature)
 - Self-Attested photographs of the student (five copies)
 - Self-Attested photograph of the Father / Mother / Legal Guardian (two copy each) (a student cannot become the local guardian)
 - Copy of the mark sheet of the previous year/semester (applicable for 2nd 3rd & 4th year students only)
 - CUET Mark sheet (applicable for 1st year only)
 - A student must produce their local guardian living inside the 60km at the day of admission.
4. **Address proof of Parents / Legal Guardian (any one of the following)**
 - Self-Attested copy of the Aadhaar Card
 - Self-Attested copy of the Election Card/ Ration Card/ Passport/etc.
 - Proof of Parent's present address
 - In the absence of the above, an Affidavit on a non-judicial stamp paper of Rs. 10 has to be submitted.
5. **Hostel Fees- Students have to pay the fees online using the link provided after the document verification. The entire fees have to be paid at the time of admission.**
